- GEO CC-WG established in March 2020 under GEO Foundational Tasks / Engagement Priorities Coordination, and overseen by GEO
  Programme Board
- ToR: CC-WG aims to develop and implement a comprehensive strategy to advance the use of EO in support of climate adaptation and mitigation including actions related to the Paris Agreement. In this way the WG will support the translation of the Canberra Declaration into concrete actions within the 2020-2022 GEO Work Programme
- Call for members launched in March 2020 gathered 90+ members including national experts and key climate partners: ESA CCI, CEOS, UNFCCC, GCOS...
- First CC-WG meeting on 3 June 2020 provided overview of functions, and proposed roadmap to make WG operational
- · Online questionnaire collected WG members' ideas on subgroups and actions
- 4 subgroups established, and 4 co-chairs elected to lead subgroups
